PRIVACY POLICY

This privacy policy ("Policy") describes how AltaClaro, Inc. and its related companies ("Company") collect, use and share personal information of consumer users of this website, www.altaclaro.com (the "Site"). This Policy also applies to any of our other websites that post this Policy. This Policy does not apply to websites that post different statements.

WHAT WE COLLECT

We get information about you in a range of ways.

- Information You Give Us- We collect your name, email address, username, password, and other information you directly give us on our Site.
- Information We Get from Others- We may get information about you from other sources. We may add this to information we get from this Site.
- Information Automatically Collected- We automatically log information about you and your computer. For example, when visiting our Site, we log your computer's operating system type, browser type, browser language, pages you viewed, how long you spent on a page, access times, Internet protocol (IP) address, and information about your use of and actions on our Site.
 - Cookies- We may log information using "cookies." Cookies are small data files stored on your hard drive by a website. Cookies help us make our Site and your visit better. We use cookies to see which parts of our Site people use and like and to count visits to our Site. We also use cookies for targeting advertising by third party providers we work with.
 - Web Beacons- We may log information using digital images called Web beacons on our Site or in our emails. We use Web beacons to manage cookies, count visits, and to learn what marketing works and what does not. We also use Web Beacons to tell if you open or act on our emails.

USE OF PERSONAL INFORMATION

We use your personal information as follows:

- We use your personal information to operate, maintain, and improve our sites, products, and services.
 - We use your personal information to process and deliver contest entries and rewards.
 - We use your personal information to respond to comments and questions and provide customer service.
 - We use your personal information to send information including confirmations, invoices, technical notices, updates, security alerts, and support and administrative messages.
 - We use your personal information to communicate about promotions, upcoming events, and other news about products and services offered by us and our selected partners. In some cases, this data may be used by third party partners we hire to target advertising by us to you on other sites based on your activity.
 - We use your personal information to provide and deliver products and services customers request.

SHARING OF PERSONAL INFORMATION

We may share personal information as follows:

- We may share personal information with your consent. For example, you may let us share personal information with others for their own marketing uses. Those uses will be subject to their privacy policies.
- We may share personal information when we do a business deal, or negotiate a business deal, involving the sale or transfer of all or a part of our business or assets. These deals can include any merger, financing, acquisition, or bankruptcy transaction or proceeding.

 - We may share information to comply with laws.
 - We may share information to respond to lawful requests and legal processes.
 - We may share information to protect the rights and property of SlideRule Labs, Inc., our agents, customers, and others. This includes enforcing our agreements, policies, and terms of use.
 - We may share information in an emergency. This includes protecting the safety of our employees and agents, our customers, or any person.
- We may share information with those who need it to do work for us.
- We may also share aggregated and/or anonymized data with others for their own uses.
